

SOUNDBOARD PRIZE DRAW RULES

1. PRIZE DRAW PERIOD: SoundBoard will conduct monthly prize draws (“**Prize Draws**”) during the Prize Draw period which starts at 00:00:01 on 1st January 2017 and ends at 23:59:59 on 31st December 2017 (the “**Prize Draw Period**”). The Prize Draws are sponsored and promoted by Global (“**Global**”) and administered by Vision Critical Communications Inc. (“**VCCI**”). Global is solely responsible for the delivery of prizes to winners. These Prize Draw Rules, together with Global’s standard competition terms and conditions (which can be found by clicking here) (“**Competition Terms and Conditions**”) apply to the Prize Draws and each Entrant (as defined below), by participating in a Survey (as defined below), agrees to be bound by them.

2. ENTRANTS: An Entrant will be any person who (i) is invited by VCCI to complete an advertiser’s survey (“**Survey**”), (ii) is eligible to complete the Survey and (iii) successfully completes the Survey in any month during the Prize Draw Period. Each Entrant will be automatically entered into the Prize Draw relating to that month. Any Entrant who successfully completes more than one Survey in a month shall be automatically entered into that month’s Prize Draw as many times as the number of Surveys he or she has completed.

3. ELIGIBILITY: Eligibility criteria will differ from Survey to Survey but all Entrants must (i) be 15 years of age or over, at the time of taking a Survey and (ii) not be an employee (as defined in the Competition Terms and Conditions), agent or representative of Global, VCCI or any of their subsidiaries or affiliates or of their respective advertising and promotion agencies or a Family Member (as defined in the Competition Terms and Conditions) or cohabitee of any such employee, agent or representative. Each Prize Draw will be held in Vancouver, Canada after the end of each month and winners shall be drawn randomly from all eligible entries received.

4. PRIZES: Five prizes of £100 cash cheques (the “**Prizes**”) shall be awarded in respect of each Prize Draw.

5. PRIZE AWARDING:

5.1 VCCI will notify each winner by email within 15 days of the relevant Prize Draw. If a winner cannot be contacted within the 15-day period, VCCI reserves the right to select another eligible Entrant for that Prize. Each winner will have seven days from notification to accept the Prize, in accordance with the instructions given in the notification.

5.2 Prizes will be awarded only on verification by VCCI that all Prize Draw requirements have been met by the winners including, without limitation, consent to the Declaration and Release Conditions provided by VCCI. The Declaration and Release Conditions shall require the winner, without limitation, to (i) release and discharge Global, VCCI and their affiliates, subsidiaries and their respective advertising and promotional agencies from all claims, demands, damages, actions and causes of action arising or to arise by reason of the acceptance or use of the Prize and (ii) give permission to Global and VCCI, at their option, to publish or otherwise use the Entrant’s first name, last name initial and comments, without compensation, in any publicity carried out by Global or VCCI or their respective advertising agencies. If any winner fails to meet any requirement the winner will forfeit his or her right to the Prize and an alternative winner will be chosen at random from the other eligible Entrants.

5.3 Each Prize will be delivered to the winner within 6-8 weeks of receipt by Global Radio of the Declaration and Release Consent. All decisions made by VCCI are final.

5.4 Each Prize must be accepted as awarded and no substitution will be made. In no event will any additional or alternative prizes be awarded.

5.5 No correspondence will be entered into except via the email address listed on the VCCI website or as otherwise notified to the Winner.

9.2 In the event any part of the Prize Draw is compromised by virus, bugs, non-authorized human intervention or other causes beyond the control of VCCI which, in the sole opinion of VCCI, corrupts or impairs the administration, security, fairness or proper entry into a Prize Draw, VCCI reserves the right, in its sole discretion, to suspend or terminate the Prize Draw and to award Prize(s) to individuals selected at random from the pool of Entrants received up to termination.

10.1 Neither Global nor VCCI shall be liable for (i) late, lost, misdirected or unsuccessful efforts to notify a winner, (ii) lost, interrupted or unavailable network server or other connections, (iii) miscommunications, (iv) failed telephone or computer or telephone transmissions or technical failure, (v) jumbled, scrambled or misdirected transmissions or (vi) any other error of any kind whether human, mechanical, electronic or otherwise.

10.2 Neither Global nor VCCI shall be liable to Entrants for any losses, damages or costs incurred (i) as a result of entering the Prize Draw, (ii) in relation to a Prize or (iii) the failure by Global to deliver a Prize to a winner in accordance with these Prize Draw Rules.
